Summary Public Assessment Report

Brinzolamide/Timolol AZAD
Brinzolamide, timolol maleate

Eye drops, suspension, 10 mg/ml + 5 mg/ml

This is a summary of the public assessment report (PAR) for Brinzolamide/Timolol AZAD. It explains how Brinzolamide/Timolol AZAD was assessed and its authorisation recommended as well as its conditions of use. It is not intended to provide practical advice on how to use Brinzolamide/Timolol AZAD.

For practical information about using Brinzolamide/Timolol AZAD, patients should read the package leaflet or contact their doctor or pharmacist.

What is Brinzolamide/Timolol AZAD and what is it used for?

Brinzolamide/Timolol AZAD is a 'hybrid medicine'. This means that it is similar to a reference medicine containing the same active substances. The company has provided additional own data to demonstrate therapeutic equivalence between Brinzolamide/Timolol AZAD and the reference medicine.

The reference medicine for Brinzolamide/Timolol AZAD is AZARGA. Brinzolamide/Timolol AZAD used to treat high pressure in the eyes, also called glaucoma or ocular hypertension (a disease where the pressure in the eye rises because fluid cannot drain out of the eye), in adult patients that are more than 18 years of age and in whom high pressure in the eyes cannot be controlled effectively by one medicine alone.

How does Brinzolamide/Timolol AZAD work?

Brinzolamide/Timolol AZAD contains two active substances, brinzolamide and timolol, which work together to reduce pressure within the eye. The two substances work by reducing the production of the aqueous humour (the watery fluid in the eye) in different ways. The combination of the two active substances has an additive effect, reducing the pressure inside the eye more than either medicine alone.

How is Brinzolamide/Timolol AZAD used?

The pharmaceutical form of Brinzolamide/Timolol AZAD is eye drops, suspension, for ocular use.

Please read section 3 of the package leaflet for detailed information on dosing recommendations, the route of administration, and the duration of treatment.

The medicine can only be obtained with a prescription.

What benefits of Brinzolamide/Timolol AZAD have been shown in studies?

Because Brinzolamide/Timolol AZAD is a hybrid application and is considered to be therapeutically equivalent, to the reference product AZARGA, their benefits and risks are taken as being the same as those of the reference medicine.

What are the possible side effects of Brinzolamide/Timolol AZAD?

Why is Brinzolamide/Timolol AZAD approved?

This medicine is similar to a reference medicine containing the same active substances. The company has provided own data to demonstrate therapeutic equivalence between Brinzolamide/Timolol AZAD and the reference medicine.

No new or unexpected safety concerns arose from the application. Therefore, the Medical Products Agency in Sweden decided that Brinzolamide/Timolol AZAD's benefits are greater than its risks and recommended that it be approved for use.

What measures are being taken to ensure the safe and effective use of Brinzolamide/Timolol AZAD?

A risk management plan has been developed to ensure that Brinzolamide/Timolol AZAD is used as safely as possible. Based on this plan, safety information has been included in the summary of product characteristics and the package leaflet for Brinzolamide/Timolol AZAD, including the appropriate precautions to be followed by healthcare professionals and patients.

Known side effects are continuously monitored. Furthermore new safety signals reported by patients/healthcare professionals will be monitored/reviewed continuously as well.
