

Part VI: Summary of the risk management plan

This is a summary of risk management plan (RMP) for Cyanocobalamin 1mg Film Coated Tablets.

The RMP details important risks of Cyanocobalamin 1mg Film Coated Tablets, how these risks can be minimised, and how more information will be obtained about Cyanocobalamin 1mg Film Coated Tablet's risks and uncertainties (missing information).

Cyanocobalamin 1mg Film Coated Tablets' summary of product characteristics (SmPC) and its package leaflet give essential information to healthcare professionals and patients on how Cyanocobalamin 1mg Film Coated Tablets should be used.

Important new concerns or changes to the current ones will be included in updates of Cyanocobalamin 1mg Film Coated Tablets' RMP.

I. The medicine and what it is used for

Cyanocobalamin 1mg Film Coated Tablets are indicated for the treatment of hematological, neurological and other symptoms due to vitamin B12 deficiency. Malabsorption of vitamin B12, for example due to lack of intrinsic factor (pernicious anaemia), gastrectomy or small intestinal disease. Also in patients receiving aminosalicylic acid therapy which may impair B12 absorption (see SmPC for the full indication).

It contains Cyanocobalamin as the active substance, and it is given by oral route of administration.

II. Risks associated with the medicine and activities to minimise or further characterise the risks

Important risks of Cyanocobalamin 1mg Film Coated Tablets, together with measures to minimize such risks and, the proposed studies for learning more about Cyanocobalamin 1mg Film Coated Tablets' risks are outlined below.

Measures to minimise the risks identified for medicinal products can be:

- Specific information, such as warnings, precautions, and advice on correct use, in the package leaflet and SmPC addressed to patients and healthcare professionals;
- Important advice on the medicine's packaging;
- The authorised pack size — the amount of medicine in a pack is chosen so to ensure that the medicine is used correctly;
- The medicine's legal status — the way a medicine is supplied to the patient (e.g., with or without prescription) can help to minimise its risks.

Together, these measures constitute routine risk minimisation measures.

In addition to these measures, information about adverse reactions is collected continuously and regularly analysed, so that immediate action can be taken as necessary. These measures constitute routine pharmacovigilance activities.

II.A List of important risks and missing information

Important risks Cyanocobalamin 1mg Film Coated Tablets are risks that need special risk management activities to further investigate or minimise the risk, so that the medicinal product can be safely taken. Important risks can be regarded as identified or potential. Identified risks are concerns for which there is sufficient proof of a link with the use of Cyanocobalamin 1mg Film Coated Tablets. Potential risks are concerns for which an association with the use of this medicine is possible based on available data, but this association has not been established yet and needs further evaluation. Missing information refers to information on the safety of the medicinal product that is currently missing and needs to be collected (e.g., on the long-term use of the medicine):
