This is a summary of the public assessment report (PAR) for Escitalopram Lundbeck. It explains how Escitalopram Lundbeck was assessed and its authorisation recommended as well as its conditions of use. It is not intended to provide practical advice on how to use Escitalopram Lundbeck.

For practical information about using Escitalopram Lundbeck, patients should read the package leaflet or contact their doctor or pharmacist.

What is Escitalopram Lundbeck and what is it used for?

Escitalopram Lundbeck is used in the treatment of depression (major depressive episodes) and anxiety disorders (such as panic disorder with or without agoraphobia, social anxiety disorder, generalised anxiety disorder and obsessive-compulsive disorder) in adults above 18 years of age.

How does Escitalopram Lundbeck work?

Escitalopram Lundbeck contains the active substance escitalopram. Escitalopram Lundbeck belongs to a group of antidepressants called selective serotonin reuptake inhibitors (SSRIs). These medicines act on the serotonin-system in the brain by increasing the serotonin level. Disturbances in the serotonin-system are considered an important factor in the development of depression and related diseases.

It may take a couple of weeks before you start to feel better. Continue to take Escitalopram Lundbeck even if it takes some time before you feel any improvement in your condition.

How is Escitalopram Lundbeck used?

The pharmaceutical form of Escitalopram Lundbeck is oral drops, solution.

Please read section 3 of the package leaflet for detailed information on dosing recommendations, the route of administration, and the duration of treatment.

The medicine can only be obtained with a prescription.

What benefits of Escitalopram Lundbeck have been shown in studies?

Escitalopram Lundbeck oral drops, solution 20 mg/ml is a different strength and pharmaceutical form compared to the already approved medicinal product Escitalopram Lundbeck film-coated tablets. The company's own data on efficacy and safety studies previously approved for the Escitalopram Lundbeck film-coated tablets is applicable for Escitalopram Lundbeck oral drops, solution 20 mg/ml as well. Therefore, it is considered that

Escitalopram Lundbeck oral drops, solution 20 mg/ml is effective in treating depression and anxiety disorders in adults above 18 years of age.

What are the possible side effects of Escitalopram Lundbeck?

Why is Escitalopram Lundbeck approved?

The effect of Escitalopram Lundbeck oral drops, solution 20 mg/ml, in the treatment of depression and anxiety disorders in adults above 18 years of age was considered to be the same as the effect of the previously approved Escitalopram Lundbeck film-coated tablets. Therefore, the Medical Products Agency in Sweden decided that Escitalopram Lundbeck's benefits are greater than its risks and recommended that it be approved for use.

What measures are being taken to ensure the safe and effective use of Escitalopram Lundbeck?

A risk management plan has been developed to ensure that Escitalopram Lundbeck is used as safely as possible. Based on this plan, safety information has been included in the summary of product characteristics and the package leaflet for Escitalopram Lundbeck, including the appropriate precautions to be followed by healthcare professionals and patients.

Known side effects are continuously monitored. Furthermore new safety signals reported by patients/healthcare professionals will be monitored/reviewed continuously as well.

Other information about Escitalopram Lundbeck

The marketing authorisation for Escitalopram Lundbeck was granted on 2007-03-02 in Sweden.
