This module reflects the scientific discussion for the approval of Icatibant Teva B.V.. The procedure was finalised on 2021-06-02. For information on changes after this date please refer to the module 'Update'.

I. INTRODUCTION

Based on the review of the quality, safety and efficacy data, a marketing authorisation has been granted for Icatibant Teva B.V., 30 mg, solution for injection in pre-filled syringe.

The active substance is icatibant acetate. A comprehensive description of the indication and posology is given in the SmPC.

For recommendations to the marketing authorisation not falling under Article 21a/22a/22 of Directive 2001/83/EC and conditions to the marketing authorisation pursuant to Article 21a/22a/ 22 of Directive 2001/83/EC to the marketing authorisation, please see section VI.

The application for Icatibant Teva B.V., 30 mg, solution for injection in pre-filled syringe, is a generic application made according to Article 10(1) of Directive 2001/83/EC. The applicant, Teva B.V., applies through the Decentralised Procedure with Sweden acting as reference member state (RMS). The concerned member state (CMS) is DE.

The reference medicinal product chosen for the purposes of establishing the expiry of the data protection period is Firazyr, 30 mg solution for injection in pre-filled syringe, authorised in the Union since 2008, with Shire Pharmaceuticals Ireland Limited as marketing authorisation holder.

Potential similarity with orphan medicinal products

Authorised orphan-designated medicinal product: TAKHZYRO

The applicant refers to the European Public Assessment Report for Takhzyro where it is stated that the CHMP by consensus is of the opinion that TAKHZYRO is not similar to Firazyr within the meaning of Article 3 of Commission Regulation (EC) No. 847/200.

Firazyr contains the same active substance (Icatibant) as Icatibant Teva B.V. and the indication of Firazyr is identical to that of Icatibant Teva B.V. (*According to the SmPC of Firazyr, it is indicated for symptomatic treatment of acute attacks of hereditary angioedema (HAE) in adults, adolescents and children aged 2 years and older, with C1-esterase-inhibitor deficiency*).

Therefore, with reference to the opinion of CHMP and to Article 8 of Regulation (EC) No. 141/2000, the existence of any market exclusivity for Takhzyro in the treatment of hereditary angioedema (HAE) does not prevent the granting of the marketing authorisation of Icatibant Teva B.V. This finding is without prejudice to the outcome of the scientific assessment of the marketing authorisation application.

II. QUALITY ASPECTS

II.1 Drug Substance

The structure of the drug substance has been adequately proven and its physico-chemical properties are sufficiently described.

The manufacture of the drug substance has been adequately described and satisfactory specifications have been provided for starting materials, reagents and solvents.

The drug substance specification includes relevant tests and the limits for impurities and degradation products have been justified. The analytical methods applied are suitably described and validated.

Stability studies confirm the retest period.

II.2 Medicinal Product

The medicinal product is formulated using excipients listed in section 6.1 in the Summary of Product Characteristics.

The manufacturing process has been sufficiently described and critical steps identified.

The tests and limits in the specification are considered appropriate to control the quality of the finished product in relation to its intended purpose.

Stability studies have been performed and data presented support the shelf life and special precautions for storage claimed in the Summary of Product Characteristics, sections 6.3 and 6.4.

III. NON-CLINICAL ASPECTS

Pharmacodynamic, pharmacokinetic and toxicological properties of active substance are well known. As active substance is a widely used, well-known active substance, no further studies are required, and the applicant provides none. Overview based on literature review is, thus, appropriate.

Environmental Risk Assessment (ERA)

Since Icatibant Teva B.V. is a generic product, it will not lead to an increased exposure to the environment. An environmental risk assessment is therefore not deemed necessary.

IV. CLINICAL ASPECTS

Pharmacokinetics

For this type of product, no bioequivalence studies are required according to the Guideline on the investigation of Bioequivalence (CPMP/EWP/QWP/1401/98 Rev. 1). The medicinal product is to be administered as a subcutaneous solution containing the same active substance in the same concentration as the currently authorised product. The product also contains the same excipients in similar amounts as the reference product. The absence of bioequivalence studies is acceptable.

Pharmacodynamics/Clinical efficacy/Clinical safety

No new studies on pharmacodynamics, clinical efficacy or clinical safety have been submitted, which is acceptable.

Risk Management Plan

The MAH has submitted a risk management plan, in accordance with the requirements of Directive 2001/83/EC as amended, describing the pharmacovigilance activities and interventions designed to identify, characterise, prevent or minimise risks relating to Icatibant Teva B.V..

Safety specification

The following Summary of safety concerns is presented in Icatibant Teva B.V. RMP:

Pharmacovigilance Plan

Routine pharmacovigilance is suggested, and no additional pharmacovigilance activities are proposed by the applicant, which is endorsed.

Risk minimisation measures

Routine risk minimisation is suggested, and no additional risk minimisation activities are proposed by the applicant, which is endorsed.

Summary of the RMP

The updated Risk Management Plan, version 1.1 signed 21 December 2020 is considered acceptable. “Effect on reproductive hormone levels in pubertal/ post-pubertal children” has now been included as an Important potential risk, thus aligning the safety specification to that of the originator product. No other RMP updates are considered needed.

The MAH has satisfactorily responded to the questions raised and updated the RMP accordingly.

The MAH shall perform the required pharmacovigilance activities and interventions detailed in the agreed RMP presented in Module 1.8.2 of the Marketing Authorisation and any agreed subsequent updates of the RMP.

An updated RMP should be submitted:

- At the request of the RMS;
- Whenever the risk management system is modified, especially as the result of new information being received that may lead to a significant change to the benefit/risk profile or as the result of an important (pharmacovigilance or risk minimisation) milestone being reached.

If the dates for submission of a PSUR and the update of a RMP coincide, they can be submitted at the same time, but via different procedures.

V. USER CONSULTATION

The package leaflet has been evaluated via a user consultation study in accordance with the requirements of Articles 59(3) and 61(1) of Directive 2001/83/EC. The language used for the purpose of user testing the PIL was English. The results show that the package leaflet meets the criteria for readability as set out in the Guideline on the readability of the label and package leaflet of medicinal products for human use.

VI. OVERALL CONCLUSION, BENEFIT/RISK ASSESSMENT AND RECOMMENDATION

The quality of the generic product Icatibant Teva B.V. is found adequate. There are no objections to approval from a non-clinical and clinical point of view. The product information is acceptable. The application is therefore recommended for approval.
