This is a summary of the public assessment report (PAR) for Ivermectin Newbury. It explains how the assessment was made and why the authorisation was recommended as well as the conditions of use. It is not intended to provide practical advice on how to use the product.

For practical information about the use of the product, patients should read the package leaflet or contact their doctor or pharmacist.

What is Ivermectin Newbury and what is it used for?

The product is a 'hybrid medicine'. This means that it is similar to a reference medicine containing the same active substance.

The reference medicine for the product is Soolantra.

Ivermectin Newbury should be used in adults only (18 years of age or older).

How does Ivermectin Newbury work?

Ivermectin Newbury contains the active substance ivermectin that belongs to a group of medicines called avermectins. The cream is used on the skin to treat pimples and spots found with rosacea.

How is Ivermectin Newbury used?

The pharmaceutical form is cream for topical use.

Please read section 3 of the package leaflet for detailed information on dosing recommendations, the route of administration, and the duration of treatment.

The medicine can only be obtained with a prescription in Sweden.

What benefits of Ivermectin Newbury have been shown in studies?

Because the product is a hybrid application and is considered to be therapeutically equivalent to the reference product Soolantra, the benefits and risks are taken as being the same as those of the reference medicine.

What are the possible side effects from Ivermectin Newbury?

Why is Ivermectin Newbury approved?

It was concluded that, in accordance with EU requirements, the product has been shown to have comparable quality and is similar to the reference medicine. Therefore, the Swedish Medical Products

Agency decided that, as for Soolantra, the benefits are greater than its risks and recommended that it can be approved for use.

What measures are being taken to ensure the safe and effective use of Ivermectin Newbury?

A risk management plan has been developed to ensure that the product is used as safely as possible. Based on this plan, safety information has been included in the summary of product characteristics and the package leaflet, including the appropriate precautions to be followed by healthcare professionals and patients.

Known side effects are continuously monitored. Furthermore, new safety signals reported by patients/healthcare professionals will be monitored/reviewed continuously as well.
