This is a summary of the public assessment report (PAR) for Ramipril/Amlodipine Proton Pharma. It explains how Ramipril/Amlodipine Proton Pharma was assessed and its authorisation recommended as well as its conditions of use. It is not intended to provide practical advice on how to use Ramipril/Amlodipine Proton Pharma.

For practical information about using Ramipril/Amlodipine Proton Pharma, patients should read the package leaflet or contact their doctor or pharmacist.

What is Ramipril/Amlodipine Proton Pharma and what is it used for?

Ramipril/Amlodipine Proton Pharma is used to treat hypertension (high blood pressure), in patients whose blood pressure is adequately controlled with amlodipine and ramipril given concurrently at the same dose level as in Ramipril/Amlodipine Proton Pharma, but as a separate medicines.

How does Ramipril/Amlodipine Proton Pharma work?

Ramipril/Amlodipine Proton Pharma contains two active substances: ramipril and amlodipine.

Ramipril works by:

- Decreasing your body's production of substances that could raise your blood pressure
- Making your blood vessels relax and widen
- Making it easier for your heart to pump blood around your body

Amlodipine works by:

- Relaxing and widening blood vessels, so that blood passes through them more easily.

How is Ramipril/Amlodipine Proton Pharma used?

The pharmaceutical form of Ramipril/Amlodipine Proton Pharma is hard capsules for oral use.

Please read section 3 of the package leaflet for detailed information on dosing recommendations, the route of administration, and the duration of treatment.

The medicine can only be obtained with a prescription.

What benefits of Ramipril/Amlodipine Proton Pharma have been shown in studies?

Because Ramipril/Amlodipine Proton Pharma is used for patients whose blood pressure is adequately controlled with amlodipine and ramipril given concurrently but as a separate medicines, studies in patients have been limited to tests to determine that Ramipril/Amlodipine Proton Pharma is bioequivalent to the use of the combination of

separate medicines containing amlodipine and ramipril respectively. The medicines are bioequivalent when they produce the same levels of the active substances in the body.

What are the possible side effects of Ramipril/Amlodipine Proton Pharma?

Why is Ramipril/Amlodipine Proton Pharma approved?

It was concluded that Ramipril/Amlodipine Proton Pharma has been shown to be bioequivalent to the use of the combination of separate medicines containing amlodipine and ramipril respectively. Therefore, the Medical Products Agency in Sweden decided that the benefits for Ramipril/Amlodipine Proton Pharma are greater than its risks and recommended that it can be approved for use.

What measures are being taken to ensure the safe and effective use of Ramipril/Amlodipine Proton Pharma?

A risk management plan has been developed to ensure that Ramipril/Amlodipine Proton Pharma is used as safely as possible. Based on this plan, safety information has been included in the summary of product characteristics and the package leaflet for Ramipril/Amlodipine Proton Pharma, including the appropriate precautions to be followed by healthcare professionals and patients.

Known side effects are continuously monitored. Furthermore new safety signals reported by patients/healthcare professionals will be monitored/reviewed continuously as well.

Other information about Ramipril/Amlodipine Proton Pharma

The marketing authorisation for Ramipril/Amlodipine Proton Pharma was granted on 2014-10-09 in Sweden.
