Part VI: Summary of the risk management plan

Summary of risk management plan for Sacubitril/ Valsartan Reddy 24 mg/26 mg, 49 mg/51 mg, 97 mg/103 mg film-coated tablets (Hereinafter referred to as Sacubitril/ Valsartan Reddy)

This is a summary of the risk management plan (RMP) for Sacubitril/ Valsartan Reddy. The RMP details important risks of Sacubitril/ Valsartan Reddy, how these risks can be minimised, and how more information will be obtained about Sacubitril/ Valsartan Reddy's risks and uncertainties (missing information).

Sacubitril/ Valsartan Reddy's summary of product characteristics (SmPC) and its Package Leaflet (PL) give essential information to healthcare professionals and patients on how Sacubitril/ Valsartan Reddy should be used.

Important new concerns or changes to the current ones will be included in updates of Sacubitril/ Valsartan Reddy's RMP.

I. The medicine and what it is used for

Sacubitril/ Valsartan Reddy is indicated in adult patients for treatment of symptomatic chronic heart failure with reduced ejection fraction.

Sacubitril/ Valsartan Reddy is indicated in children and adolescents aged one year or older for treatment of symptomatic chronic heart failure with left ventricular systolic dysfunction (see SmPC for the full indication). It contains Sacubitril/ Valsartan as the active substance and it is given by oral route.

II. Risks associated with the medicine and activities to minimise or further characterise the risks

Important risks of Sacubitril/ Valsartan Reddy, together with measures to minimise such risks and the proposed studies for learning more about Sacubitril/ Valsartan Reddy's risks, are outlined below.

Measures to minimise the risks identified for medicinal products can be:

- Specific information, such as warnings, precautions, and advice on correct use, in the PL and SmPC addressed to patients and healthcare professionals;
- Important advice on the medicine's packaging;
- The authorised pack size - the amount of medicine in a pack is chosen so to ensure that the medicine is used correctly;
- The medicine's legal status - the way a medicine is supplied to the patient (e.g. with or without prescription) can help to minimise its risks.

Together, these measures constitute *routine risk minimisation* measures.

In addition to these measures, information about adverse reactions is collected continuously and regularly analysed, so that immediate action can be taken as necessary. These measures constitute *routine pharmacovigilance activities*.

If important information that may affect the safe use of Sacubitril/ Valsartan Reddy is not yet available, it is listed under 'missing information' below.

II.A List of important risks and missing information

Important risks of Sacubitril/ Valsartan Reddy are risks that need special risk management activities to further investigate or minimise the risk, so that the medicinal product can be safely administered. Important risks can be regarded as identified or potential. Identified risks are concerns for which there is sufficient proof of a link with the use of Sacubitril/ Valsartan Reddy. Potential risks are concerns for which an association with the use of this medicine is possible based on available data, but this association has not been established yet and needs further evaluation. Missing information refers to information on the safety of the medicinal product that is currently missing and needs to be collected (e.g. on the long-term use of the medicine);
