Summary of risk management plan for Safinamide Win Medica 50 mg, 100 mg filmdragerad tablett (Safinamide)

This is a summary of the risk management plan (RMP) for Safinamide Win Medica 50 mg, 100 mg filmdragerad tablett [Safinamide Win Medica]. The RMP details important risks of Safinamide Win Medica, how these risks can be minimised, and how more information will be obtained about Safinamide Win Medica's risks and uncertainties (missing information).

Safinamide Win Medica's summary of product characteristics (SmPC) and its package leaflet give essential information to healthcare professionals and patients on how Safinamide Win Medica should be used.

Important new concerns or changes to the current ones will be included in updates of Safinamide Win Medica's RMP.

I. The medicine and what it is used for

Safinamide Win Medica is authorised for the treatment of adult patients with idiopathic Parkinson's disease (PD) as add-on therapy to a stable dose of levodopa (L-dopa) alone or in combination with other PD medicinal products in mid-to late-stage fluctuating patients.

It contains safinamide as the active substance and it is given orally.

II. Risks associated with the medicine and activities to minimise or further characterise the risks

Important risks of Safinamide Win Medica, together with measures to minimise such risks and the proposed studies for learning more about Safinamide Win Medica's risks, are outlined below.

Measures to minimise the risks identified for medicinal products can be:

- Specific information, such as warnings, precautions, and advice on correct use, in the package leaflet and SmPC addressed to patients and healthcare professionals;
- Important advice on the medicine's packaging;
- The authorised pack size — the amount of medicine in a pack is chosen so to ensure that the medicine is used correctly;
- The medicine's legal status — the way a medicine is supplied to the patient (e.g. with or without prescription) can help to minimise its risks.

Together, these measures constitute *routine risk minimisation* measures.

In addition to these measures, information about adverse reactions is collected continuously and regularly analysed, so that immediate action can be taken as necessary. These measures constitute *routine pharmacovigilance activities*.

If important information that may affect the safe use of Safinamide Win Medica is not yet available, it is listed under 'missing information' below.

II.A List of important risks and missing information

Important risks of Safinamide Win Medica are risks that need special risk management activities to further investigate or minimise the risk, so that the medicinal products can be safely taken. Important risks can be regarded as identified or potential. Identified risks are concerns for which there is sufficient proof of a link with the use of Safinamide Win Medica. Potential risks are concerns for which an association with the use of these medicines is possible based on available data, but this association has not been established yet and needs further evaluation. Missing information refers to information on the safety of the medicinal products that is currently missing and needs to be collected (e.g. on the long-term use of the medicines).
